1. 手續費 (銀行及本公司收取) Handling fee (Bank charges and ESFL's service fee) i) 本地銀行匯款轉賬不收費，部份銀行所需的到賬時間為兩個工作日。No handling fee for withdrawal by Bank Remittance Transfer and the arrival time is two working days for some of local banks. ii) 特快轉賬(CHATS)/電匯(TT)提取港元、人民幣或美元每次收取港幣 350 元/美金 45 元。Handling fee is HK\$350/ US\$45 per transaction to withdraw HKD/CNY/USD by CHATS or Telegraphic Transfer. iii) 特快轉賬(CHATS)/電匯(TT)提取新加坡元或日圓每次收取港幣 380 元，收費以等值匯款貨幣收取。Handling fee is HK\$380 per transaction to withdraw SGD/JPY by CHATS or Telegraphic Transfer, the fee is charged in the equivalent currency of the withdrawal. (如收款銀行拒收而出現退回情況，已收取手續費將不予退回) (The handling fee is not refundable if the transaction is rejected and returned by the receiving bank.)
